### Overview

Angel Taveras focuses his practice on complex commercial and government litigation, elections and voting rights litigation, campaign finance, municipal restructuring, public finance, pensions, and public infrastructure.

Angel served as the 37<sup>th</sup> Mayor of Providence, Rhode Island, from 2011 to 2015. As mayor, he led a city government with 5700 employees and a budget of \$678 million and is credited with saving the city from the brink of bankruptcy. Under his leadership, Providence was recognized with the All-America City Award from the National Civic League, was the recipient of a \$3 million award from the Carnegie Foundation to create innovative high schools and received the City Livability Award at the U.S. Conference of Mayors. In addition, Common Cause Rhode Island honored Angel with their Excellence in Public Service Award for his service as Mayor.

Angel has served as an adjunct professor for Providence College.
