## Overview

Stephen D. Lapatin is a litigator who represents clients in Rhode Island and Massachusetts state and federal courts. His practice includes matters involving <u>complex commercial and business litigation</u>, <u>intellectual property litigation</u>, white collar criminal defense and government investigations, employment disputes, real property disputes and land use matters, and tort actions. Stephen provides advice and counsel to clients at all stages of litigation using a strategic and personalized approach.

Stephen also spearheads the firm's **government relations group**. He represents businesses and organizations in a variety of industries—primarily banking, health care, pharmaceutical, and retail and wholesale trade—and advocates on their behalf before the Rhode Island General Assembly, Office of the Governor, and various state agencies, to achieve their legislative goals and interests.

Before joining AP&S in 2020, Stephen served as a law clerk to the Honorable Maureen McKenna Goldberg of the Rhode Island Supreme Court. He is a *summa cum laude* graduate of Roger Williams University School of Law, where he served as the Editor-in-Chief of the Law Review, and a former student-athlete and graduate of the University of Rhode Island.

# Experience

- Represented an organization of hundreds of landlords and property owners in a case involving a constitutional challenge to a short-term rental ordinance enacted by the Town of Narragansett, and successfully obtained an injunction in the R.I.
